### **New Building/Home:**

(plans must be 1/4" scale)

- Site Plan
  - Doesn't have to be 1/4" scale but must have property line measurements
  - DO NOT MEASURE FROM CURB. MUST BE FROM FRONT OF PROPERTY LINE
- Footing & Foundation Details
- Floor Plans (all levels)
- Elevations
- Wall Sections
- Landscape Plan
- Pictures of Site
  - Prior to NEW construction – colored & labeled
  - From street towards lot (from entrance of site), and from lot (all directions)
